1. NAME OF THE SOCIETY :- "YUVA KHEL FOUNDATION "
2. REGISTERED OFFICE :- The Registered office of the Society shall be situated at Banshi Kothi, L.T.L. Hostel Gate No.93, Digha, Patna-800011 (Bihar). The Registered office may be changed at any time by the Society and it will be intimated to L.G. Registration, Bihar, within 15 days of such change.
3. AREA OF OPERATION :- The area of operation shall be all over India.
4. AIMS & OBJECTIVE :- Aims & objectives of the Society are as follows :-
Foundation shall function to propagate and promote the All Sports (Kheli) known as all objective of the foundation shall be to inspire, Induce and conduct the following operations:

 - e) To conduct interstate matches and training camp.

 - g) The foundation will work for the development of rural urban, tribal and slum area people of all communities without caste, creed or sex for all round development in the field of Sports, education, health improvement, sanitation, environment, cultural development, Socio economic problem and problem of unemployment among the association.
 - h) To help to the player and arrange Scholarship, Medal and award such time to time.
 - i) To organize regional, state level and International level tournament every year.
 - j) To manage, maintain and run senior and junior level sports academy, school, college and university in every state and trained youth and children for best player.
 - k) To organized (men, women and children) sports programme for their moral, mental and physical development.

- n) To help to the all kinds of people during natural calamities like flood, fire, famine, cyclone, earthquake, cold, drought and provide medicine, food, safe drinking water and rehabilitation centre and distributed blankets, cloths and other things in the Society by organizing seminar & workshop.

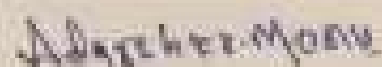

AMENDED RULES & REGULATIONS
OF
YUVA KHEL FOUNDATION

1. DEFINITIONS:-

- A) Society means :- " YUVA KHEL FOUNDATION "
- B) Committee means :- The Managing Committee of the society.
- C) Office bearer means :- President, Vice President, Secretary, Joint Secretary and Treasurer.
- D) Year means :- From 1st April to 31st March.
- E) Body means :- The General Body of the society.
- F) Act. means :- Societies Registration Act. of 21, 1860.

2. MEMBERSHIP :-

Any Indian citizen not below the 18 years of age and who are interested in social welfare work and follow the rules and regulations of the association will obtain membership of the association, who shall pay monthly subscription of Rs.500/- monthly and Rs.1000/- for admission fee.

A person desirous of joining the Society shall apply in writing on a prescribed form to the Secretary of the Managing Committee who shall forward the same to the Managing Committee and shall be entitled to reject or accept the same without assigning any reason thereof.

3. TERMINATION OF MEMBERSHIP:-

- A) Resigns or dies or becomes unsound of mind or bankrupt.
- B) By a competent court sentenced to imprisonment for any offence involving moral turpitude.
- C) If found by the Managing committee to be engaged in activities which are against the interest of the association.
- D) Any member in default in payment of monthly subscription for a period exceeding three months shall automatically cease to be a member.

4. APPLICATION FOR ADMISSION :-

- A) Every application for the admission as member of the association shall be addressed to the Secretary of the Society.
- B) No application shall be considered unless the applicant is proposed by a member and seconded by another such member.
- C) Every such application shall be considered in the meeting of the Managing Committee and shall be accepted or rejected by a vote of majority save as those failing under rules-4 of these rules.
- D) Every applicant shall be informed in writing by the Secretary about the decision of the Managing Committee which shall be final.

- iii) Special General Meeting of the Society may be called by the President or the Secretary by giving not less than 15 days notice in writing to the members.
- iv) $\frac{3}{5}^{\text{th}}$ of the valid members of the Society may requisition meeting of the general body by submitting a written and signed requisition to the Secretary/ President of the Society.

10. NOTICE :-

- i) Notice of every meeting stating the general particulars of all matters to be transacted at such meeting shall be delivered or sent by post to each member.
- ii) 15 clear days notice specifying the place, date, time and nature of matter shall be given to the members by post or by hand delivery.
- iii) In case of emergent meeting the same can be convened by giving a notice of 24 hours only.
- iv) 7 days notice will be given to the members for Managing Committee Meeting of the society.

11. QUORUM :-

$\frac{2}{3}^{\text{rd}}$ members present and entitled to vote shall form a quorum at any meeting. If at an extraordinary meeting there is no quorum within half an hour the meeting shall stand dissolved. If at any Annual General Body meeting there is no quorum within half an hour for the time fixed, the meeting shall be adjourned and no quorum will be necessary for an adjourned meeting.

12. SOURCE OF INCOME :-

- i) Fees and monthly subscriptions.
- ii) Income from Operational activities.
- iii) By donations/Grants/assistance from Union/State Govt./Private organisation involved in promotion of sports.
- iv) Grant and Aid from any other legal sources.
- v) Grant and Aid from any other legal sources.
- vi) Other income, if any, from legitimate means.
- vii) Income from advertisement, sponsorship etc.

13. BANK OPERATION :-

The Bank account of the Society shall be kept in the name of the Association in any Nationalized Bank and shall be operated joint signature of two office bearers President, Secretary & Treasurer.

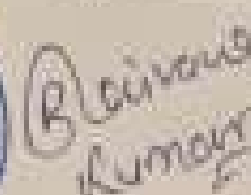
